Weekly Vendor Requirements

Weekly food vendors must have necessary permits through the Douglas County Health Department and comply with all health & safety regulations. Permits may take up to 2 weeks for approval.

Vendors must provide the management office with a current certificate of liability insurance. Omaha Public Market should be included as "Additional Insured." The general liability policy must have a minimum coverage of \$1,000,000 individual/\$2,000,000 aggregate.

Vendor agrees to indemnify and hold harmless the Omaha Public Market, Inc., Friends of the Omaha Public Market and Vic Gutman & Associates, its employees, volunteers, and sponsors, from any and all causes of action which may arise from the operation of this Farmers Market, not caused by negligence of the Omaha Public Market, Inc., and Vic Gutman & Associates, and their employees, volunteers or sponsors. I grant permission for Omaha Public Market, Inc. (Omaha Farmers Market) to use any photos, videotape, etc. taken of my products or me in any and all publicity and advertising promoting the Market. *By submitting this application, I acknowledge that the agreement has been read and understood, and I will abide by the terms presented in the Permitted Products Information, Vendor Rules & Regulations, and as directed by Market Management.*
